If your firm has been certified by the Interstate Certification process, you must submit your request to your home state.

If the firm is also certified as a DBE in the District of Columbia, only one affidavit will be required for continued eligibility and certification in the SBE Program. Please be advised that you will receive a renewal letter triennially after the DCUCP's three-year review.
